**STATE OF WEST VIRGINIA,
COUNTY OF KANAWHA, to wit:**

I, BREN J. POMPONIO, hereby state that the following facts are true to the best of my knowledge and belief:

1. That I am a practicing attorney in Charleston, West Virginia, and I am presently Litigation Director for Mountain State Justice, Inc. I have been a member of the West Virginia Bar since October 1998. I am also admitted to practice before the United States Court of Appeals for the Fourth Circuit, the United States District Court for the Southern District of West Virginia, and the United States District Court for the Northern District of West Virginia.

2. That I graduated from the West Virginia University College of Law in the top three in my class and graduated Order of the Coif. I was managing editor of the West Virginia Law Review.

3. That after graduation from law school, I served as a law clerk for The Honorable Joseph R. Goodwin and The Honorable Charles H. Haden II, Chief Judge of the United States District Court for the Southern District of West Virginia.

4. That I have extensive experience serving as counsel for employment cases, including serving as class counsel in multiple employment cases.

5. That, as a significant part of my practice, I represent clients in cases filed pursuant to fee-shifting statutes.

6. That I have been qualified by the Circuit Court of Kanawha County, West Virginia, and have testified as an expert on the market rate for consumer attorneys in West Virginia. *See State ex rel. Morrissey v. Cashcall, Inc.*, No. 08-C-00964, slip op. at 3 (Cir. Ct. Kan. Cty. Mar. 13, 2013).

7. That I have conducted trainings and continuing legal education both locally in West Virginia, regionally, and at national conferences including classes specifically focused on attorney's fees recoverable in cases.

8. That, as a result, I am very familiar with the prevailing market rates for attorney's fees in West Virginia.

9. During the course of this litigation and compiling my time records, I have sought to exercise billing judgment and have declined to record time for time expended on short phone calls and other matters marginally related to this litigation. I have sought to keep a minimum the number of billed hours.

10. No part of any fee award will inure to my personal benefit.

11. In communications with other attorneys in the area – specifically, David Grubb, John W. Barrett, Anthony Majestro, and Jason Causey – I am informed that the market rate in this

community for an attorney with my level of experience and academic background is \$400-450.00 per hour. This range of rates has been actually billed for and received by attorneys in this area with my experience level. My current hourly rate is \$425/hour.

12. As Litigation Director for Mountain States Justice, Inc., I directly supervise and am personally familiar with the legal work of Aubrey Sparks, Jennifer S. Wagner, Daniel F. Hedges, Michael Nisam Sabat, and Laura Davidson. I have reviewed the time expended and the rates that they seek in this case. In my professional opinion the following hourly rates are reasonable for the following lawyers who have worked on this case:

- (a) Aubrey Sparks: \$250;
- (b) Jennifer Wagner: \$360;
- (c) Daniel F. Hedges: \$495;
- (d) Michael Nisam-Sabat: \$300; and
- (e) Laura Davidson: \$250.

13. That in my professional opinion, the hourly rates sought by the following lawyers is reasonable:

- (a) John Stember: \$495;
- (b) Maureen Davidson-Welling: \$400;
- (c) Vincent J. Mersich: \$400;
- (d) Timothy F. Cogan: \$450; and
- (e) F. Alex Risovich: \$300

14. Further, it is my professional opinion that the rate of \$130/hour is reasonable for the paralegals and interns who have worked on this case.

15. That I am also aware of fee decisions involving other lawyers in West Virginia, including the following, which given the experience level of the lawyers and an adjustment for inflation, support the requests of the lawyers involved in this case.

- a. In 2011, the Ohio County Circuit Court awarded Wheeling attorney James Bordas an hourly rate of \$400. *See* Order of February 17, 2011, *Brown v. Quicken Loans, Inc., et al.*, Civil Action No. 08-C-36 (Recht, J.);
- b. Also in 2011, the Kanawha County Circuit Court awarded Princeton attorney Kay Bayless \$300 per hour in an employment discrimination case. The Court awarded a twenty-five percent lodestar enhancement to account for delay in payment and contingency risk, resulting in an effective hourly rate of \$375. *See* Order of January 28, 2011, *Richard Wayne Bevelle v. Par Electrical Contractors, Inc.*, Civil Action No. 08-AA-88 (Zakaib, J.);
- c. Further, the Jackson County Circuit Court awarded Charleston attorney Mark Atkinson \$450 per hour in an employment discrimination case. *See* Order of June 7, 2010, *Rice v. Burke-Parsons-Bowlby Corporation, et al.*, Civil Action No. 09-C-41;
- d. Similarly, the Boone County Circuit Court awarded Mr. Atkinson \$450 per hour in another employment discrimination case in 2010. *See* Order of November 19, 2010, *Smith v. CSX Transportation, Inc.*, Civil Action No. 08-C-96 (Thompson, J.); and
- e. The Ohio County Circuit Court awarded Wheeling attorney Thomas Schultz \$400 per hour in an insurance bad faith case in 2004. *See* Order of May 7, 2004, *Nationwide Mutual Insurance Company v. Robinson*, Civil Action No. 03-C-442 (Gaughan, J.).

16. I have reviewed the time records contemporaneously kept by me involved in the above-styled matter. Time and expense records demonstrate the following fees incurred by Plaintiff's Class Counsel in this matter to date:
