Plaintiff's Motion for Preliminary Approval - Granted.

Plaintiff Regina Renee Blackwell moves the court for entry of an order preliminarily approving the class action and PAGA settlement reached. The moving papers offer that a copy of the proposed settlement and information regarding the preliminary approval hearing were submitted to the LWDA via online submission. The settlement was reached through mediation and the key settlement terms are as follows:

Estimated number of class members: approximately 2173 individuals;

Gross settlement amount: \$412,500 on an all-inclusive, non-reversionary basis;

Settlement administration costs: not to exceed \$21,000;

Requested class representative service payments: \$7,500 to Plaintiff Blackwell;

Requested attorney's fees and costs: \$137,500 (one-third of the gross settlement amount), plus costs not to exceed \$25,000;

PAGA penalties: \$20,000, 75% (\$15,000) of which will be paid to the LWDA, with the remaining 25% (\$5,000) paid to Aggrieved Employees;

Estimated Net Settlement Amount: \$201,500.00.
