PLEASE TAKE NOTICE that on February 20, 2024, at 11:00 a.m. or as soon thereafter as this matter may be heard in Department 11 of the above-captioned Court, located at located at 312 North Spring Street, Los Angeles, CA 90012, the Honorable David S. Cunningham presiding, plaintiffs James Wedel, Charles McWhales, Simon Mashian, Fausto Hernandez, Michaela Vivant, Marjan Svetko, and Pei en Chong Sampson (collectively, "Plaintiffs") will and hereby do move for an order granting preliminary approval of the proposed class action settlement ("Settlement").
