4 motion for preliminary approval of class action and PAGA settlement in this matter.


5 Prior to the hearing, the Court published its Tentative Ruling, a copy of which is attached

The court grants the motion as follows:</p> <p>\$2,500.00 for enhancement payment to plaintiff (not to exceed);</p> <p>\$33,333.33 for attorneys' fees (not to exceed 1/3 of gross settlement amount);</p> <p>\$5,000.00 for litigation costs (not to exceed);</p> <p>\$10,000.00 for settlement administration costs (not to exceed); and</p> <p>\$10,000.00 total PAGA penalties (\$7,500.00 to the LWDA).</p> <p>The final approval hearing is scheduled for <u>January 30, 2025 at 2:00 p.m.</u> in Department CX104. The motion for final approval shall be filed at least 16 court days before the hearing.</p> <p>Plaintiff is ordered to give notice, including to the LWDA, and to file a proof of service.</p>


