1 A hearing concerning Round One of the Payment Distribution took place at 9:00 a.m.,
2 on December 11, 2023, in Department 7 of the Los Angeles County Superior Court, the
3 Honorable Lawrence P. Riff presiding.

4 David Ginsburg of Roxborough, Pomerance, Nye & Adreani, LLP, Michael Liskow of
5 George Feldman McDonald, PLLC, and Scott Priz of Priz Law, LLC appeared for Named
6 Plaintiffs. R. Timothy O'Connor appeared for Defendant

7 After reviewing the Joint Declaration of David R. Ginsburg and Michael Liskow
8 Regarding Class Settlement Payment Disbursement, the Declaration of Jeremy Talavera on
9 Behalf of CPT Group, Inc. Regarding Class Settlement Payment Disbursement, and conferring
10 with counsel, the Court rules as follows:

11 1. Unless otherwise defined herein, all capitalized words and terms in this Order
12 shall have the same meanings as set forth in the Amended Settlement Agreement (“Settlement
13 Agreement”) filed on October 26, 2022.

14 2. More than \$500,000 remains in the Settlement Fund Account after the first
15 distribution of settlement payments.

16 3. There shall be a second distribution of these remaining funds after the Claims
17 Administrator, CPT Group, Inc., deducts its fee, which is not to exceed \$88,500.

18 4. This second distribution shall only go to those Participating Settlement Class
19 Members who timely cashed their Settlement Payment checks during the first distribution,
20 rather than going to all Participating Settlement Class Members.

21 5. On or before September 12, 2024, the Parties shall file a joint report or
22 declaration with the Court that sets forth the total amount that was actually paid to the
23 Participating Settlement Class Members who timely cashed their Round One and Round Two
24 Settlement Payment checks, the total number of Participating Settlement Class Members who
25 cashed Round One and Round Two checks (and the total amount of such checks), the number of
26 Round Two checks returned as undeliverable (and the total amount of such checks), the number
27 of Round Two checks voided due to not being timely cashed (and total amount of such checks),

1 and the total dollar amount of monies (including any accrued interest) remaining in the
2 Settlement Fund Account.

3 6. The Court shall conduct a hearing concerning Round Two of the Payment
4 Distribution on September 19, 2024, at 9:00 a.m. in Department 7 of the Spring Street
5 Courthouse.

6 7. The Parties may request an earlier hearing date by posting such a request to the
7 Court through CaseAnywhere.

8 8. The Claims Administrator shall post this Order on the settlement website,
9 [www.https://www.cptgroupcaseinfo.com/SCIFSettlement.com](https://www.cptgroupcaseinfo.com/SCIFSettlement.com), forthwith.

10 9. The Claims Administrator shall post the date for the next hearing on the
11 settlement website, [www.https://www.cptgroupcaseinfo.com/SCIFSettlement.com](https://www.cptgroupcaseinfo.com/SCIFSettlement.com), forthwith.
