

This Amended Judgement is entered in accordance with the Court's April 24, 2024 Order granting Plaintiff's Motion for Final Approval of Class Action Settlement.

On April 24, 2024, this Court granted the Parties' stipulated request for an alternative distribution of uncashed settlement checks to a designated *cy pres* beneficiary, Legal Aid at Work. Upon entry of this Amended Judgment, the Settlement Administrator is approved to distribute the uncashed funds of \$12,157.62 to the *cy pres* recipient, Legal Aid at Work. Once this Amended Judgment is entered, the clerk is directed to send a copy to the Judicial Council pursuant to Code of Civil Procedure section 384.5.

Without affecting the finality of this Amended Judgment, the Court shall retain exclusive and continuing jurisdiction over the above-captioned action and the parties for purposes of enforcing the terms of the Amended Judgment. This document shall constitute a judgement (and separate document constituting said judgment) for purposes of California Rules of Court, Rule 3.769(h).
