1 In light of the parties' stipulation regarding scheduling the hearing of the motions for final
2 approval and attorneys' fees and to allow adequate time for class members to elect to opt out,
3 challenge calculation of settlement shares, and object to the settlement, the Court hereby amends
4 the schedule as follows:

- 5 1. the motion for final approval, currently scheduled to be filed by March 3, 2023, will be
6 reset to March 17, 2023;
- 7 2. should any class member file a timely opt out or objection after March 17, 2023, the
8 parties will address such matters in a supplemental brief to be filed by April 6, 2023;
9 and
- 10 3. the motions for final approval of the class action settlement and for attorneys' fees and
11 class representative service awards, currently scheduled for March 30, 2023 at 10:00
12 a.m., will be rescheduled for hearing on April 13, 2023 at 10:00 a.m. in Courtroom 8,
13 19th Floor in San Francisco.
- 14 4. the parties must update the Class Action Settlement Notice to reflect the new final
15 approval hearing date, April 13, 2023 at 10:00 a.m. in Courtroom 8, 19th Floor in San
16 Francisco. (See Dkt. No. 181 at 11.)
