JUDGMENT

Pursuant to the Order Granting Final Approval of Class Action Settlement entered on July 30, 2024, it is hereby ORDERED, ADJUDGED AND DECREED as follows:

1. Judgment in this matter is entered in accordance with the Court’s Order Granting Final Approval of Class Action Settlement and the parties’ Amended Class and PAGA Action Settlement Agreement and Release (“Settlement Agreement”). Unless otherwise provided herein, all capitalized terms used herein shall have the same meaning as defined in the Settlement Agreement.

2. As provided by the Order Granting Final Approval of Class Action Settlement, all Participating Class Members are permanently barred and enjoined from prosecuting, pursuing, or seeking to reopen, any of the Released Class Claims against Defendant and the Released Parties, as defined in the Settlement Agreement.¹ Consistent with the definitions provided in the Settlement Agreement, the Settlement Class consists of: All current and former non-exempt hourly employees of Defendant working in Ralphs division stores in the State of California at any time during the period of from July 23, 2015 to March 9, 2022.

3. As provided by the Order Granting Final Approval of Class Action Settlement, all PAGA Members are permanently barred and enjoined from prosecuting pursuing, or seeking to reopen, any of the Released PAGA Claims against Defendant and the Released Parties, as defined in the Settlement Agreement. Consistent with the definitions provided in the Settlement Agreement, the aggrieved employees or PAGA Members consist of: Ralphs PAGA Members: All current and former non-exempt hourly employees of Defendant in working in Ralphs division stores in the State of California at any time during the period from November 9, 2013 to March 9, 2022; and Food 4 Less

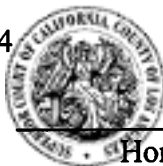
4 4. Without affecting the finality of the Judgment, the Court shall retain exclusive and
5 continuing jurisdiction over the above-captioned action and the parties, including all Class Members
6 and PAGA Members, for purposes of enforcing the terms of the Judgment entered herein.

8 5. This document shall constitute a Judgment for purposes of California Rules of
9 Court, Rule 3.769(h).

10 6. Pursuant to California Rules of Court, Rule 3.771(b), the settlement administrator is
11 ordered to post on the settlement administrator's website a copy of this Judgment for a period of thirty
12 days from the date the Court signs the Judgment.
