	STIPULATION RE: CORRECTION OF ERROR IN SETTLEMENT AGREEMENT AND RELEASE
I	

This stipulation is entered into by and between Plaintiffs Richard Snow, Allan Ortega, and Willie Germany, and Defendant Watkins & Shepard Trucking, Inc. (collectively the "Parties"), through their respective counsels of record, for purposes of correcting a typographical error in their Stipulation for Settlement and Release of Class and Representative Action Claims, Conditional Consolidation of Cases for Settlement Purposes, and Leave to Conditionally File Consolidated Complaint for Settlement Purposes (the "Settlement Agreement" or "Agreement").

7 WHEREAS, on or about December 16, 2020, the Parties executed the Settlement
8 Agreement;

9 WHEREAS, after executing the Agreement, counsel noticed a typographical error in
10 Paragraph 17(c), establishing the Germany Gross Settlement Fund, in which the phrase "Ortega
11 Settlement Class" is mistakenly used instead of "Germany Settlement Class."

NOW THEREFORE, to correct this error, the parties hereby stipulate and agree that
Paragraph 17(c) will be amended as follows:

14 The Germany Gross Settlement Fund: The agreed upon total amount c. 15 in full and final settlement of the Released Claims (as defined below) of the Ortega 16 Germany Settlement Class is One Hundred Forty-Five Thousand Dollars 17 (\$145,000.00) (the "Germany GSF"). The Germany GSF is inclusive of all 18 payments to be made in settlement of the Action to Germany, the LWDA, all 19 Ortega Germany Settlement Class Members, and their counsel for individual, 20 private attorney general, and class-wide relief. None of the Germany GSF will be 21 payable by Defendant prior to final approval by the Court of the settlement, 22 occurrence of the Effective Date of the settlement as defined below, and the 23 occurrence of all other conditions precedent as set forth in this Agreement as 24 approved by the Court, provided all such conditions occur prior to the Effective 25 Date.
